



## RESERVATION POLICY

- The total rental fee (incl. sales tax) holds a reservation on a Visa, MasterCard, Discover or American Express. This amount is charged to the renter's credit card at the time the reservation is made.
- The renter must be experienced in the handling and operation of the vessel, know and abide by the rules of the road. You **MUST** be 25 years old with a valid driver's license to rent a boat. Lessons are available when you do not qualify as experienced. Ask for details.
- A \$1,000 security deposit is charged to the renter's credit card prior to rental boat departure. Gas and other expenses are charged to the renter's credit card separate from the deposit. Boats must be returned to the fuel dock and will be filled upon your return. The renter is responsible for cost of fuel upon return of vessel.
- A signed contract (which includes operator's social security number) must be on file before boat departure and a copy of a valid drivers license.
- Rental boats leave the Aquebogue location at **9 am** and return at **4 pm**. Boat(s) must stay in the Peconic Bay (east to Shelter Island) and are not permitted in the Shinnecock Canal/Bay, Ocean, or LI Sound without prior written approval from Lighthouse Boat Rentals, LLC.
- Refunds are not given for unboatable weather days or boats returned early during a multiple day rental period. Unboatable days will be determined by Lighthouse Boat Rentals, LLC when it is deemed conditions are unsafe, only then will a refund be issued.
- Mid-Week Special (Tuesday, Wednesday, Thursday) 20% Off - Daily rate only! Not to be combined with already discounted rates.

## CANCELLATION POLICY

- NON-HOLIDAY reservations require 48 hour notice of cancellation to receive a refund, anything less than 48 hours notice, the customer will receive a rental credit for another day within the 2009 season.
- NON-HOLIDAY- In the event of unboatable weather as determined by Lighthouse Boat Rentals, LLC- the customer will be given the choice of either a refund or a credit for a future Rental within the 2009 season.
- **On a HOLIDAY reservation there are NO REFUNDS – NO CANCELLATIONS. Credit Only.**
- Holidays: (incl. weekend of) MEMORIAL DAY WEEKEND, 4<sup>TH</sup> OF JULY 3-6 AND LABOR DAY WEEKEND.

## LATE RETURN POLICY

Renters are charged a \$300 late fee when rental boats are returned after the **4:00 PM** return time.

## CUSTOMER RESPONSIBILITIES

- The person signing the rental agreement **MUST** be the one operating the boat or rental equipment, as this person is the one held responsible for **ALL** damages to the vessel, contents and actions of their passengers. State law requires children under the age of 12 wear a life vest while onboard.
- New York State Boating Law states that the person renting the boat is responsible for having all legally required equipment aboard and considers operating a vessel in excess of its capacity rating (combined weight of persons, motor and gear) hazardous. Standing on seats, gunwale, transom riding, and wake jumping is negligent operation.
- Lighthouse Boat Rentals, LLC reserves the right to terminate the boat rental if negligent operation occurs during the rental. Exercise courtesy and common sense.
- The renter must report any malfunction, breakdown or accident of the rental craft to Lighthouse Boat Rentals, LLC immediately.
- **ALL New York State/ Federal BWI and DWI rules apply.** The use of alcohol and/or narcotics is not permitted!
- All rental boats are checked in and checked out. The operator **MUST** be present to sign both check-in and check-out forms unless a signed disclaimer is on file.
- **NO ANIMALS** (dogs, etc) are allowed on rental boats at any time.
- Renters are responsible for cost of GAS they use and any prop damage that may occur.

**PROP DAMAGE FEES:** (+ tax) IF CHUNKS ARE MISSING OR BLADE IS TORN-UP, the renter is responsible for reconditioning charges or replacement of propeller.

**ADDITIONAL RENTAL EQUIPMENT - DAILY, 3-DAY, WEEKLY - \$25, \$50, \$95** (ski's, tubes, 2 vests, bridles and tow ropes). Renters are responsible for lost or damaged Ski and Tube Packages. Additional Life Jackets \$5 each.

**I assume all risk of personal injury or property damage and I here by agree that I am totally responsible for the safety of my family, myself and my guests. I hereby release Lighthouse Boat Rentals and Larry's Lighthouse Marina from any and all liability.**
